This privacy policy applies between you, the User of this application and OnBio Limited, the owner and provider of this application. OnBio Limited takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the application.

Data

collectively all information that you submit to OnBio Limited via the application. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;

Cookies

a small text file placed on your computer by this application when you visit certain parts of the application and/or when you use certain features of the application. Details of the cookies used by this application are set out in the clause below (**Cookies**);

Data Protection Laws

any applicable law relating to the processing of personal Data, including but not Limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;

Scope of this privacy policy

This privacy policy applies only to the actions of OnBio Limited and Users with respect to this application. It does not extend to any applications that can be accessed from this application including, but not Limited to, any links we may provide to social media applications.

For purposes of the applicable Data Protection Laws, OnBio Limited is the "data controller". This means that OnBio Limited determines the purposes for which, and the manner in which, your Data is processed.

Data collected

5.

We may collect the following Data, which includes personal Data, from you:

- name;

- Information on generators used on productions that you are representing;
- IP address (automatically collected);
- web browser type and version (automatically collected);
- operating system (automatically collected);
- a list of URLs starting with a referring site, your activity on this application, and the site you exit to (automatically collected);

in each case, in accordance with this privacy policy.

How we collect Data

6. We collect Data in the following ways: a. data is given to us by you ; and
b. data is collected automatically.

Data that is given to us by you

7.

OnBio Limited will collect your Data in a number of ways, for example:

- a. when you contact us through the application, by telephone, post, e-mail or through any other means;
- b. when you elect to receive marketing communications from us in relation to this generator data gathering project;

in each case, in accordance with this privacy policy.

Data that is collected automatically

8. To the extent that you access the application, we will collect your Data automatically, for example:

we automatically collect some information about your visit to the application. This information helps us to make improvements to application content and navigation, and includes your IP address, the date, times and frequency with which you access the application and the way you use and interact with its content.

Data retention

Your rights

19.

You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.

Right to correct - the right to have your Data rectified if it is inaccurate or incomplete.

Right to erase - the right to request that we delete or remove your Data from our systems.

Right to restrict our use of your Data - the right to "block" us from using your Data or limit the way in which we can use it.

Right to data portability - the right to request that we move, copy or transfer your Data.

Right to object - the right to object to our use of your Data including where we use it for our legitimate interests.
